Funding Priority: Student and Staff Well Being

Kids do best when they stay in school and have a safe, comfortable place to call home after the bell rings. That isn't the situation for all kids, though. Sometimes family setbacks occur and help is needed fast. Thanks to donors, the help was there.

- "Something unexpected can happen at any moment." **The Student Emergency Fund** assisted 73 families with rent assistance, utility payments, rides to school, clean linens and other items.
- Snack pantries were stocked at 22 PLCS school buildings thanks to the **Anders Food Fund**. Weekly fresh food bags with apples, carrots and bananas were sent home with 161 elementary students when school let out each weekend.
- The **PLCS Family Fund** helped 26 staff members and their families during unexpectedly hard times such as deaths in the family, illnesses and accidents.

• Since opening in 2021 with a startup grant from the Foundation, 2,200 families in need have shopped for free clothing and personal care items at the **PLCS Community Closet.** 62,000 items were given away.

Scholarships Help With Rising College Costs

Three-quarters of all 2023 PLCS graduating seniors continued on with post secondary education. Without scholarship assistance, some would have been unable to pay the growing costs of tuition and fees. Last year, 78 graduates received donor-funded Foundation scholarships to make school more affordable.



5,960 elementary students attended a field trip, show, touring production or workshop through the highly regarded Rose Theater's "Every Child" program.



Scoreboard advertisers directly assisted with the growing cost of activities for the wildly successful Monarch and Titan programs, benefiting 3,735 high school students and a loyal community of fans.

21% of all PLCS elementary students enroll in Kids Club.

The Foundation's Kids Club program meets the unique child care needs of kindergarten through 6th grade students by offering a safe, reliable program at all 16 elementary buildings. It runs during the school year, before and after school, and on select out-of-school days. Kids Club also offers a full day summer program at consolidated school sites.
